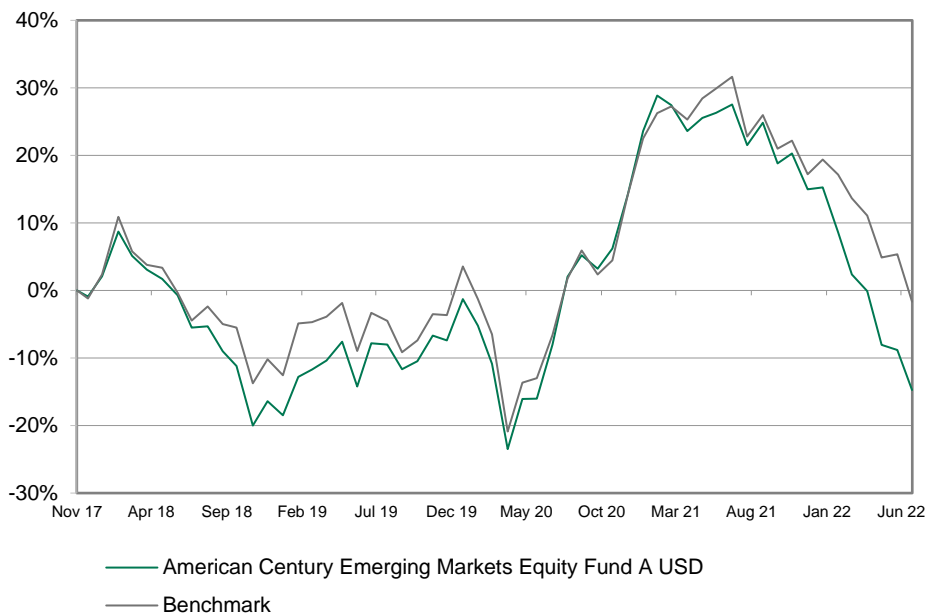

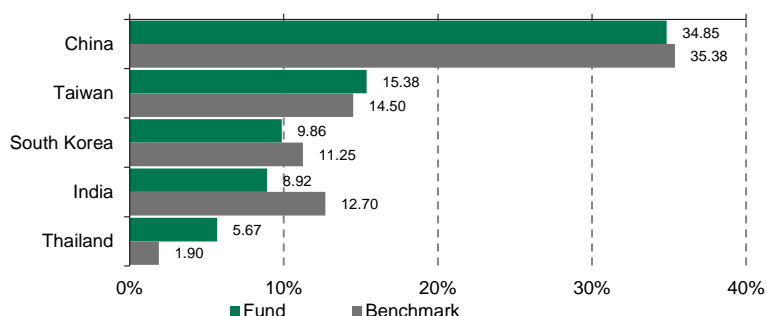

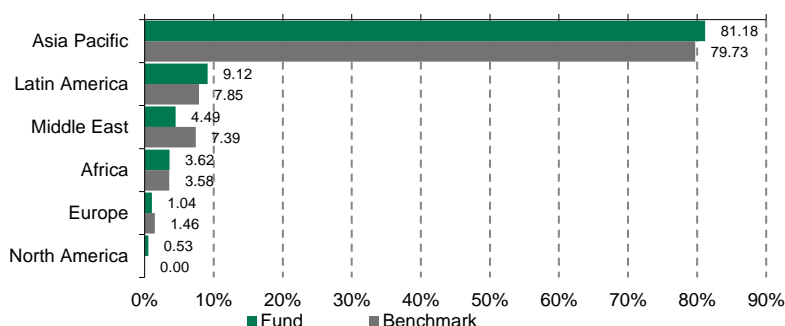

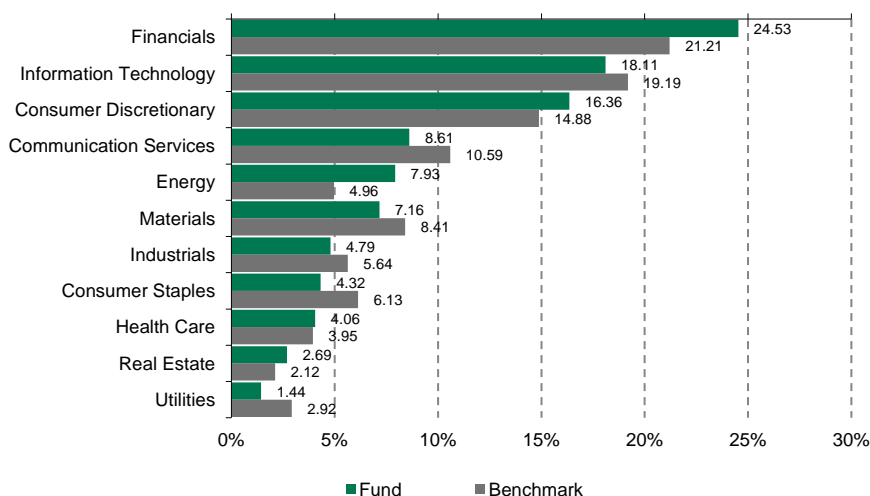
Top 5 Active Country Weights
