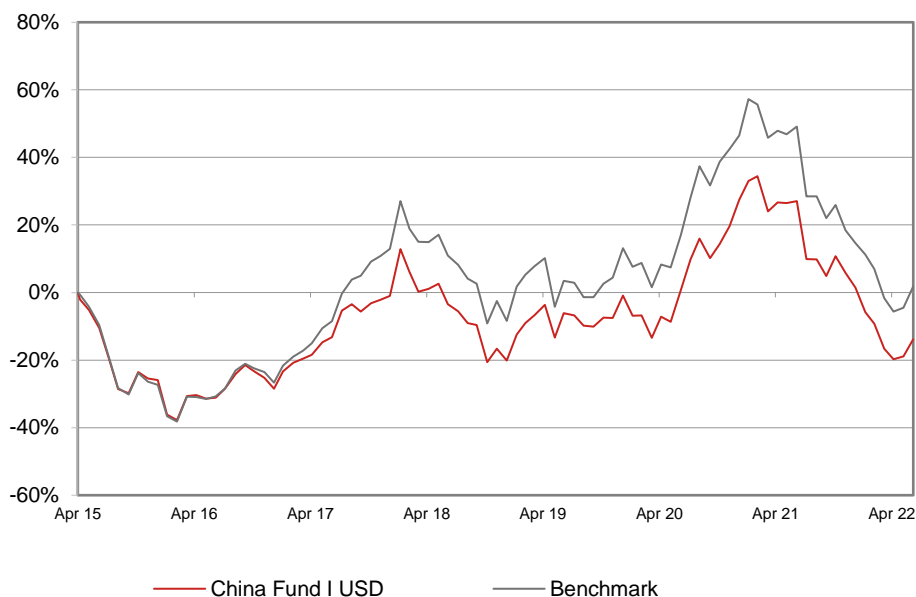


INVESTMENT OBJECTIVE

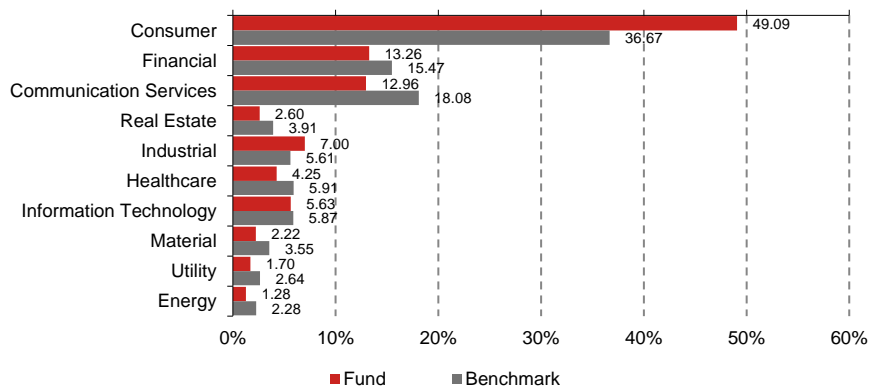
