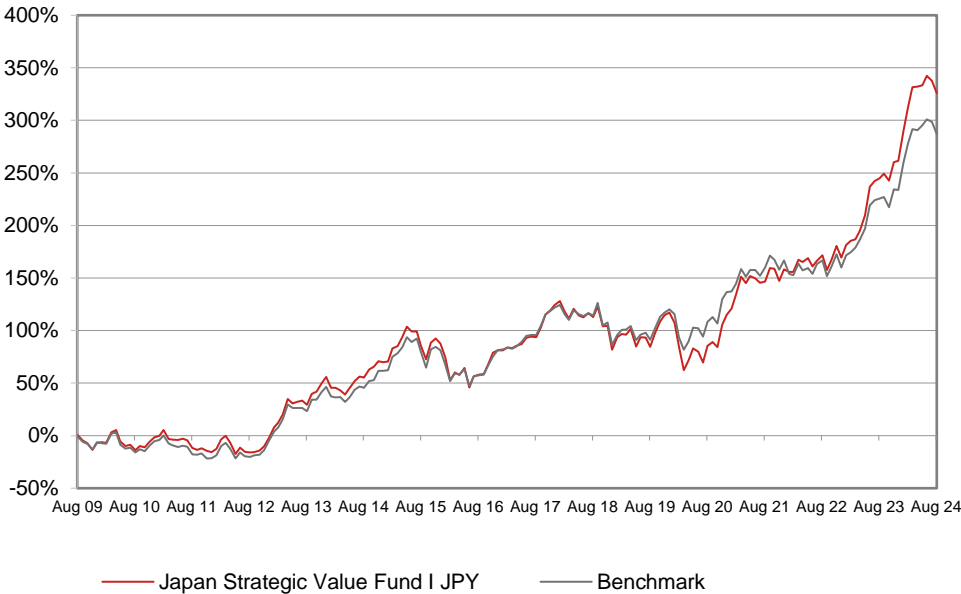


INVESTMENT OBJECTIVE

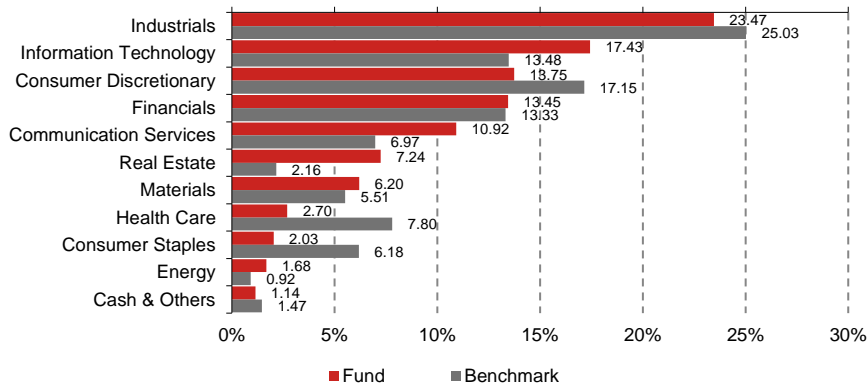
