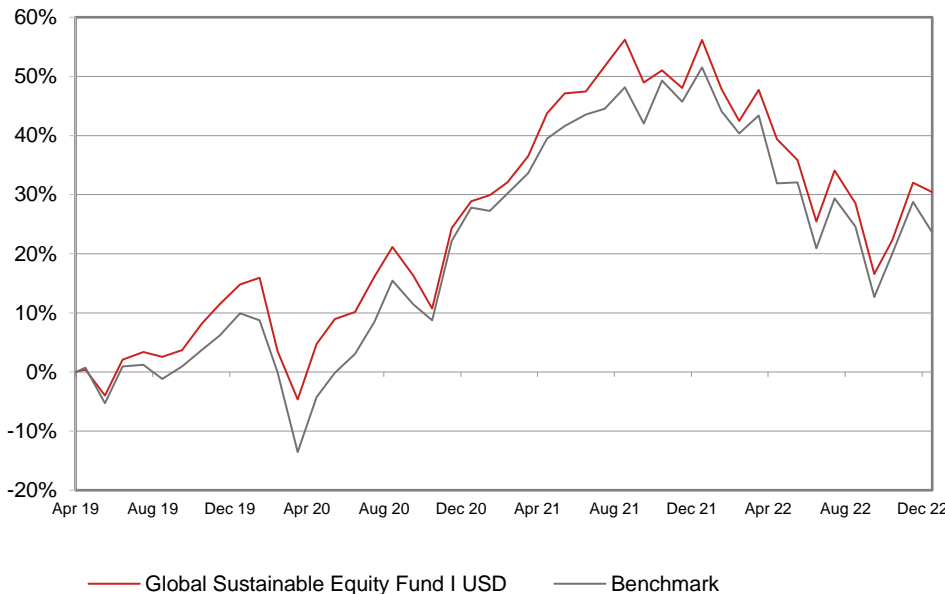


INVESTMENT OBJECTIVE

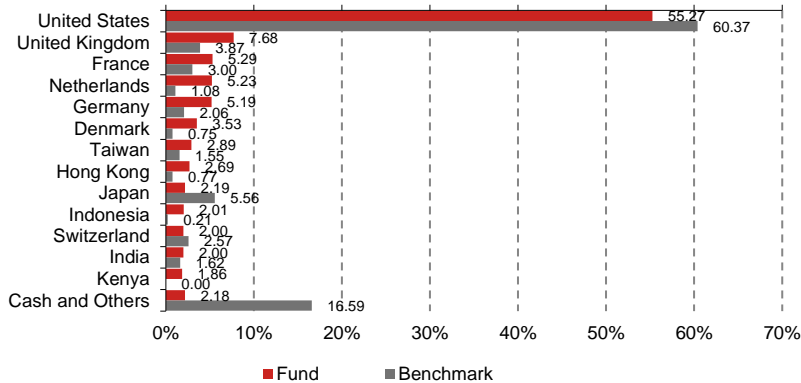

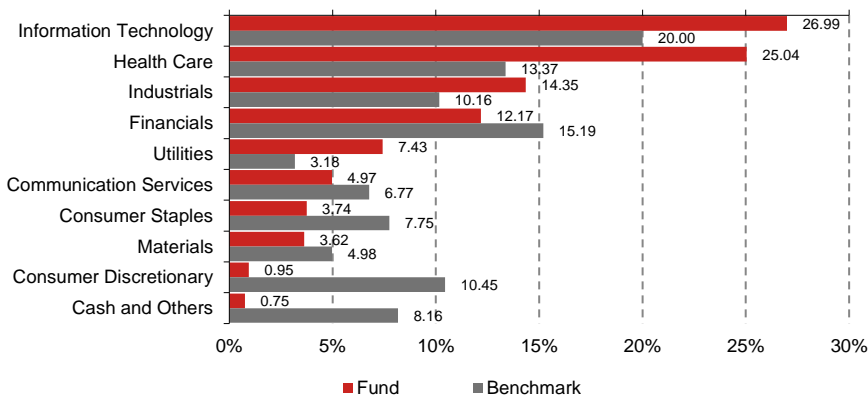
